### What details do I need to leave a gift to Cavell?

### **Raymond's Legacy**

After experiencing exceptional care in hospital during lockdown, Raymond decided to change his Will to include a generous donation of £50k to Cavell.

During Raymond's hospital stay, his son Julian said, "Dad was immensely touched by the care that he received. Being in hospital was unfamiliar to him, but he was very appreciative of the nurses who looked after him, and he wanted to do something to give back."

#### **What will your legacy be?**

In 2022, the Cavell Support team saw a 200% rise in those seeking help compared to 2021, with a notable rise in applications from working nursing and midwifery professionals. Pre-pandemic, 55% of people seeking support from Cavell were working nurses, midwives, or healthcare assistants. By the end of 2022, this had jumped to 85%, a huge rise in working staff struggling with basic living costs.
